## Center For A Non Violent Community Overview

The Center For A Non Violent Community (CNVC) actively supports the right of all people to live their lives free from interpersonal violence. We foster healthy relationships with self, partners, family, and peers. We value the feminist principles of self-empowerment over self-desertion and of shared decision-making over dominance. We are ardently dedicated to building community, which is interdependent, collaborative, respectful of diversity, and supportive of peaceful solutions to conflict.

#### Project Overview

CNVC has provided the Rape Prevention Education (RPE) program to youth in our county since 2008. This project utilizes evidence-based curriculum from "Flirting or Hurting?" written by Nan Stein and Lisa Sjostrom to create educational videos on the subject of Sexual Harassment. For the 2020-2021 grant year, CNVC will produce 3 sexual harassment prevention videos to define sexual harassment, provide real world examples for discussion and role play, and information about what to do if you or someone you know experiences sexual harassment. Each video will feature staff or community volunteers facilitating a lesson to an offscreen audience.

To better serve our community, we are seeking youth to provide input as a Youth Production Consultant. The Youth Production Consultant will provide input during the Pre and Post aspects of video production; i.e., scriptwriting, storyboarding, and support. Duration of the project will be 3 months (October 2020 – December 2020), each of the 3 videos will require approximately 10-15 hours to complete.

### Project Goals & Target Audience

CNVC hopes to continue educating youth on sexual harassment by reinforcing how to recognize, prevent, and feel empowered to do something, if a situation arises. The target audience is middle school students, grades 6-8. CNVC staff and community volunteers will facilitate the video content to be delivered to a video editing service provider. We aim to produce three 20-minute videos in the next 3 months. (October 2020 – December 2020)

### Scope of Work & Expected Deliverables

We are seeking consultation services to provide input on pre and post production of three 20-minute videos. This may include script consultation, storyboarding, and general support. CNVC reserves the right to request additions or changes to the products during the editing phase before final approval and delivery of completed product. Eligible candidates must be Tuolumne County residents between 18 to 24 years old.
